# GENERAL INSTRUCTIONS

Apply in mid winter when trees or vines are dormant. Spray coverage; A liberal application of the product is required to ensure complete coverage of all eggs.

#### MIXING INSTRUCTIONS

Pour the required amount of water into the mixing tank and while agitating, add the required amount of BioAAid Winter Oil. When using in combination with other pesticides, mix the pesticide first according to the manufacturers' instructions, then add BioAAid Winter Oil last. Maintain continuous agitation while spraying.
