DIRECTIONS FOR USE:

WEEDS CONTROLLED	RATE	CRITICAL COMMENTS
Annual Ryegrass, Silvergrass, Perennial grasses.	200mL per 100L spray solution.	For improved control of these weeds, add to recommended rates of Glyphosate 360 g/L, Glyphosate 450 g/L and dry formulations of Glyphosate herbicides. Use in accordance with herbicide label directions.

GENERAL INSTRUCTIONS:

Supa-wet TX OPE Surfactant is a low foaming non-ionic surfactant for use with a range of glyphosate Herbicides. Supa-wet TX OPE Surfactant improves the efficiency of Glyphosate Herbicides in controlling Annual Ryegrass, Silvergrass and Perennial grasses (typically from the beginning of August to the end of October). Supa-wet TX OPE Surfactant is not a general purpose surfactant and should only be used where a wetting agent is recommended for the purpose.

MIXING INSTRUCTIONS:

Add Supa-wet TX OPE Surfactant to the spray tank after the agricultural chemical has been thoroughly mixed.

STORAGE AND DISPOSAL

KEEP OUT OF REACH OF CHILDREN. Store in the closed, original container in a cool, well-ventilated area.

DO NOT store for prolonged periods in direct sunlight. Triple or preferably pressure rinse containers before disposal. Add rinsed material to the spray tank. DO NOT dispose of undiluted chemicals on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers should not be burnt.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT:

DO NOT contaminate streams, rivers or waterways with chemical or used containers.

SAFETY DIRECTIONS:

Severely irritating to eyes. Avoid contact with eyes and skin. Do not inhale spray mist. When preparing product for use, wear elbow-length PVC gloves and face shield or goggles. After use and before eating, drinking or smoking, wash hands, arms and face thoroughly with soap and water. After each day's use, wash contaminated clothing, gloves and face shield or goggles.

FIRST AID:

If poisoning occurs, contact a Doctor or Poisons Information Centre (Phone Australia 13 11 26). If skin contact occurs, remove contaminated clothing and wash skin thoroughly. If in eyes, hold eyes open, flood with water for at least 15 minutes and see a doctor.
